Issues raised

- Reference to D2 route to be changed to an option south of Saxmundham, possibly from a roundabout at the Aldeburgh turn off.
- Citizens Advice funding from SCC to be changed to 50%.
- Rewording necessary section on PCSOs and police presence.
- Support for strong argument for the need to link various public and private strategies and plans – master planning approach.
- Support for strong arguments for more mitigating improvements to infrastructure and public services, road, rail, health, police etc.
