#### 40/24PD Planning Applications

The Committee considered planning application appeal DC/23/3360/FUL—Change of use from agricultural land to dog walking facility — Agricultural land between B1121 and River Fromus. The Committee **unanimously resolved** to confirm their objection to the planning appeal. The Committee noted they are not opposed to the application in principle. The reason for the objection is because the entrance and exit to the site is via a 60mph road which is hazardous due to the topography of the area and the sight lines will offer little view of the oncoming traffic when exiting the site.

#### 41/24PD Planning Enforcement

The Committee noted the recent reports to, and responses from, East Suffolk Council's Planning Enforcement department regarding the following alleged breaches:

#### Case Reference ENF/24/0250/SIGN – Turkish Barber, High Street

Inappropriate illuminated signage, which may be in contravention of the Conservation Area and the Neighbourhood Plan.

ESC Planning Enforcement have concluded their investigation into the above breach. From the evidence gathered it has been determined that there is breach of control. The land was visited on the 27 August 2024 and the signs were viewed and photographed. It has been determined that the signs are not permitted under The Town and Country Planning (Control of Advertisements)

Inappropriate signage, which may be in contravention of the Conservation Area and the Neighbourhood Plan.

ESC Planning Enforcement cannot act on adverts displayed for over three years therefore the signs are now immune from enforcement action.
